CALL FOR PROPOSALS FOR RESEARCH FUNDING FROM SAMARBEIDSORGANET FOR THE YEAR 2025

The Central Norway Regional Health Authority (RHA) has allocated funds for strengthening research and academic development within medicine and health sciences in the region. The funding is allocated via The Liaison Committee for Education, Research and Innovation in Central Norway (Samarbeidsorganet). Subject to the financial framework for the Central Norway RHA, a call for proposals for research funding for 2025 has been approved, and includes the following categories:

1. Research fellowships*

- PhD research fellowships
- Postdoctoral research fellowship
- Researcher fellowship
- Innovation focused PhD research fellowships
- Innovation focused Postdoctoral research fellowship
- Innovation focused Researcher fellowship
- 2. Project funds
- 3. Mobility grant

Information regarding the <u>formal requirements</u> of each category is found here.

The hiring institution is responsible to follow all current laws, acts and regulations that governs the employment of candidates in fellowship positions granted of Samarbeidsorganet.

The deadline for application is 3 June 2024 at 3:00 p.m.

Strategic research areas

It is the aim of the Central Norway RHA to strengthen research in the whole region. All health trusts in Central Norway are therefore encouraged to submit applications, and to collaborate with other health trusts in the region on joint project proposals. Applications with collaboration between different sectors such as universities, private establishments, commercial businesses and municipalities are also encouraged.

Applications are expected to fall within one or more of the following strategic research areas:

- Clinical research
- Health data
- Precision medicine
- Technology in the health care services
- Research on health care services
- Mental health care and interdisciplinary specialized drug treatment
- Global health research
- Health education research

Samarbeidsorganet encourage applicants employed in health trusts to take advantage of the opportunity to use project grant funding to buy time off from clinical work for research purposes.

Applications may be submitted by employees in the following institutions:

- Health trusts (HT) in Central Norway
- Universities and university colleges in the region, in collaboration with HT in Central Norway
- Regional Private-sector parties that have an agreement with the Central Norway RHA, in collaboration with a HT in Central Norway.

The research projects must be relevant to the health services, and it is required that all projects are conducted with participation from a HT. The projects are expected to result in scientific publications where the given health trust is listed as an affiliation.

Formal requirements for the application

- 1. <u>Template for project description for application for research funds</u> from Samarbeidsorganet must be followed.
- 2. <u>Guidelines requirements and regulations for the application categories</u> must be followed [only in Norwegian]
- 3. <u>Current regulations for regional research funding from the Central Norway Regional Health</u> <u>Authority</u> [only in Norwegian] must be followed.
- 4. Documented collaboration with a health trust is a requirement. All projects must document active- cooperation and participation from at least one person employed in a HT in the region. This implies that the HT-employee must have participated actively in planning- and writing the project description and that the person in question has a central role in the project. This is to be described in the application. All project participants must confirm their participation in <u>eSøknad</u>.
- 5. Documented management commitment is a requirement. The head of clinic at the applicant institution must approve all applications. An approval indicates that the management approves of the HT-employee's contribution in the project and recognizes that participation may require clinic resources.
- 6. Applications coming from the higher education sector or private sector, must in addition include a completed *commitment form* signed by the appropriate authority of the host institution as an attachment. The deadline for approval by the head of clinic is 21 June.

Applications that do not fulfill the formal requirements will be rejected. <u>Rejection reasons are described in detail on page 4</u>

Limitation on the number of applications

One person can only submit a maximum of three applications as project manager. If several applications relate to the same main-project, the different applications must include project descriptions that clearly describes a) which applications are related to each other, and b) the unique contribution of each sub-project to the main-project.

Submitting applications

Applications is to be submitted through the health trusts' electronic application system, <u>eSøknad</u>. Choose the call «Samarbeidsorganet Helse Midt-Norge» on the front page and follow the instructions integrated in the eSøknad-system.

It is not possible to edit your application or resend documentation after the deadline has expired.

Allocation of funds

An academic committee will evaluate all applications, except for those rejected based on violation of formal requirements. The committee give their recommendations to Samarbeidsorganet based on an evaluation of the <u>scientific value</u> of each application, where the assessment of utility value and professional quality is emphasized equally. All applicants will receive a brief written feedback on their application from the committee.

Samarbeidsorganet will decide on the allocation of funds in November 2024. The allocation will be published on Central Norway RHA's website shortly after the meeting.

The projects awarded grant funds may start at the earliest 01.01.2025 and latest 01.10.2025.
